This is with reference to the proposal submitted by St. Martin's Engineering College, Dhulapally (V), Quthbullapur (M), Ranga Reddy (Dist.), Secunderabad, (Telangana) affiliated to Jawaharlal Nehru Technological University, Hyderabad under the UGC Scheme for Autonomous Colleges.

The college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.
