Increase of Intake in Existing Courses

As there is a lot of demand for seats in B.Tech (Information Technology) department, it is decided to increase the intake of Information Technology department from 60 to 180.

Starting New Courses

It is also decided to start new Post-Graduate program in M.Tech (Computer Science and Engineering) with 18 seats and new UG program B.Tech (Computer Science Information Technology) with 60 seats.

NAAC Inspection & Results

NAAC Peer Team visited the college 2nd and 3rd April, 2019 and our college is awarded A+ grade. SMEC applied for reassessment and achieved A+ from earlier B+ grading.

Autonomous Inspection and Results

The UGC Autonomous Team visited the college on 6th and 7th August 2019. The UGC has granted autonomous status to the college for a period of 10 years, which gives us freedom to achieve academic excellence by introducing latest technology in curricula, innovative practices in teaching and learning process.

JNTUH Approval of Autonomous Status

The JNT University has informed the college to follow existing university syllabus and regulation for 2019-20 admitted batch and can be revised autonomous syllabus from 20-21 admitted batch onwards.

NBA Accreditation

It is decided to register in NBA portal for fresh accreditation to CSE and MBA departments. And we need to go for re-accreditation for IT and EEE Department in the month of December, it is decided to submit compliance report as per NBA guidelines.

Hostel Facility

Hostel facility (Boys & Girls) available outside the campus. However it is decided to start Girls hostel with 350-400 capacity inside the campus.

Review of Vision, Mission and PEOs

All Departments have reviewedtheir respective Vision, Mission and PEOs based on the feedback received from various stake holders and the updated Vision, Mission and PEOs are put up to General Body for approval.

Placements

As of now the total placement count is 298 which is a good achievement and many companies are in pipelined. However, placement department is advised to update the plan to have more pre-placement offers through internships.

Feedback

Periodic feedbacks are collected from various stake holders as per the practice and analyzed summary report along with action taken was discussed. It is decided to take online feedback periodically from student about the teaching learning process.

GHMC again approved the consultancy work (Third party quality control) to us. AICTE has funded Rs. 4.08 Lakhs for conducting two weeks FDP and same has been scheduled from 9th to 21st December 2019.

We have received the approval to act as Paramarsh (Advisor) on behalf of UGC to mentor the institutions going for fresh NAAC Accreditation. Around Rs.30 Lakhs will be funded by UGC for the same purpose.
