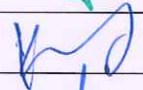


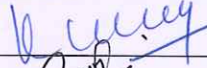
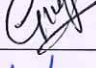
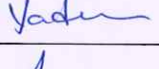
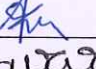
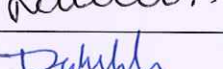
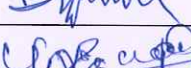
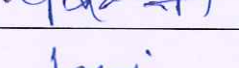
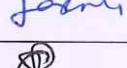
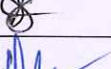
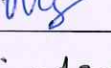
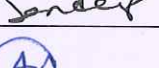


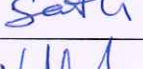


1. Review of progress on minutes of previous meeting
