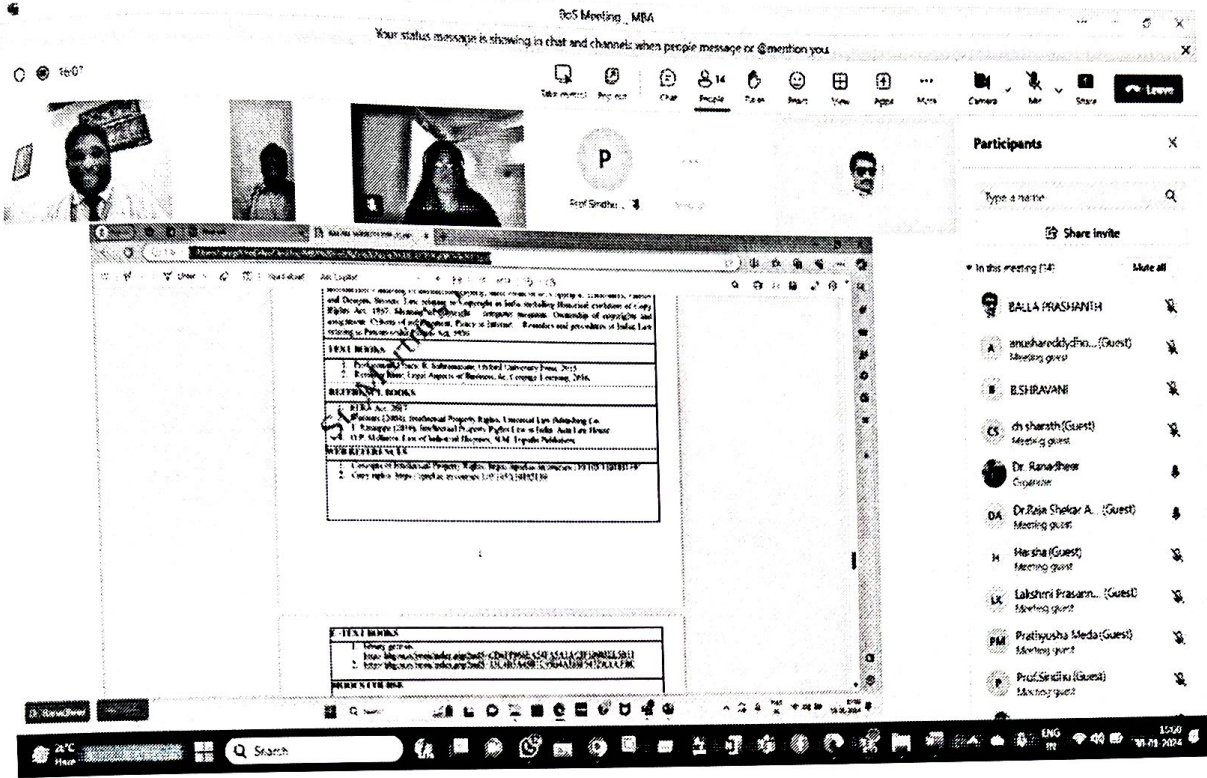
The following points are discussed during the BoS meeting:
